### 7) NCAA Explanations

- -NCAA wants coach's association or coaches involved more
- -wants girls to be given training and put through normal student athlete type of regiment, doesn't trust that we are at this point yet
- -Change of format to a bigger 6 singles 3 doubles area
- -Change of competition season to a smaller season, more meets

## 8) TWU Problem

-David and Joe addressed the problem of not being reimbursed by TWU via the rockstar sponsorship or via the TWU contract. Patti Alexander was contacted, the issue should be resolved.

# 9) ACUI/NIRSA

- -David suggests to put a plan for taking over ACUI regional levels, a goal to hit more regions with NCTTA or Table Tennis people running the regions to place more of a positive effort in well run tournaments
- -Bid guidelines for 2008 are affected with the ACUI approach
- -switch at National level easy
