

## **NCTTA COVID INFORMATION**

### **Waiver of Liability Relating to Coronavirus/COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and/or by contact with contaminated surfaces and objects, and even possibly in the air. People reportedly can be infected and show no symptoms and therefore spread the disease. The exact methods of spread and contraction are unknown. Evidence has shown that COVID-19 can cause serious and potentially life threatening illness and even death.

NCTTA cannot prevent you from becoming exposed to, contracting, or spreading COVID-19 while attending its events and or tournaments and/or entering onto premises where NCTTA's events are held.

It is not possible to prevent the presence of the disease. Therefore, if you choose to attend an event organized by NCTTA and enter onto premises where its events are held, you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

**ASSUMPTION OF RISK:** I have read and understood the above warning concerning COVID-19. I hereby choose to accept the risk of contracting COVID-19 for myself in order to attend an NCTTA event and enter the event premises. The event is of such value to me that I accept the risk of being exposed to, contracting, and/or spreading COVID-19 in order to attend in person.

I acknowledge and accept that participating in certain physical activities with regard to NCTTA events.

I also acknowledge that I am under no compulsion to undertake these risks. The inherent risks, hazards, and dangers include but are not limited to: personal injury, sprains, strains, dislocations, amputations, cuts, bruises, breaks, teeth (loosened/broken/knocked out), head injuries, concussion, paralysis, and/or death.

I understand, accept, and assume those hazards and risks, and waive all claims against NCTTA, its representatives, employees, and any other business or person connected with the NCTTA events, and of all claims for injuries or damages or otherwise, which may arise for any reason whatsoever as a result of participation in activities or at or during the NCTTA events

I am aware of the risks, dangers, and hazards associated with participating in activities at NCTTA events and I freely accept and fully assume all such risks, dangers, and hazards and the possibility of the personal injury, death, property damage or loss resulting from participating.

**WAIVER OF LAWSUIT/LIABILITY:** I hereby forever release and waive my right to bring suit against NCTTA and its owners, officers, directors, managers, officials, trustees, agents, employees, or other representatives for fault in connection with exposure, infection, and/or

spread of COVID-19 related to attending its event. I understand that this waiver means I give up my right to bring any claim based on negligence, including for personal injuries, death, disease or property losses, or any other loss, whether known or unknown, foreseen or unforeseen.

I HAVE CAREFULLY READ AND FULLY UNDERSTAND ALL PROVISIONS OF THIS RELEASE, AND FREELY AND KNOWINGLY ASSUME THE RISK AND WAIVE MY RIGHTS CONCERNING LIABILITY AS DESCRIBED ABOVE:
